Element Hitchin verify that tensile specimens of E1005 (HNBR 90A) by FCS Fluoro Carbon Seals Private Limited have been tested according to ISO 10423:2009, annex F.1.13.5.2 (immersion).

Test Conditions

Five replicate tensile dumbbells of E1005 (HNBR 90A) were exposed in the hydrocarbon liquid phase to the following conditions for 160 hours. The test was run between 16th and 24th June 2020.

Changes in physical and mechanical property levels were measured at room temperature, with non-exposed material serving as the point of reference. The material was not altered by the exposure conditions.

The acceptance criteria given in section 8.2.2 of the NORSOK M-710 standard¹ were applied. The results are tabulated below.
